ARTICLE 3 – The price includes

- "pedestrian" maritime crossings St Malo-Jersey (A/R)
- accommodation in Jersey in a 3* hotel
- meals from lunch on D1 to lunch on D5, drinks included (1/4 of wine + coffee/tea)
- the visits mentioned in the program

ARTICLE 4 – The price does not include

- transport to the ferry terminal of Saint-Malo on Day 1
- personal expenses
- everything that is not mentioned in the program
- the insurance



ARTICLE 4.1 – Options

ARTICLE 4.2 – Price changes

ARTICLE 6 – Methods of payment

TERRA MUNDI – VISIT OUEST sends participants an order form for the stay mentioned in this contract. Each participant agrees to pay by credit card or bank transfer 50% of the total amount of the stay as a deposit guide. The remaining 50% will be paid no later than May 31, 2022.

In each Participant's Order Form, the terms expressed in this Agreement shall apply.

ARTICLE 7 – Cancellation conditions

This contract, even if it is taken out individually, falls within the special conditions of sale listed below:

TOTAL CANCELLATION BY THE CUSTOMER:

- cancellation of the participant until May 31, 2022: €90.00 administration fee charged per participant
- cancellation of the participant after May 31, 2022: the total amount of the stay will be invoiced

If one of the participants is forced to cancel the stay, it is imperative to notify us immediately in writing (email, post).

ARTICLE 7.1 – In the event of COVID

If the traveler must cancel his stay if he is declared positive for Covid, the cancellation conditions of article 7 apply. If travel is prohibited by government decree, the traveler will benefit from a one-year credit from the date of end of stay.



ARTICLE 7.2 – In the event of cancellation of SPACE

If SPACE is canceled, TERRA MUNDI – VISIT OUEST is not responsible and cannot reimburse participants.

ARTICLE 8 – Conditions of modification

List of names and change of name:

List to be communicated upon receipt of the order. A name change will not result in any price increase.

Issuance and insertion of banknotes

A voucher is sent.

ARTICLE 9 – Assistance and cancellation insurance

TERRA MUNDI – VISIT OUEST can only insure customers resident in France.

ARTICLE 10 – Warranty

TERRA MUNDI – VISIT OUEST declares and guarantees that it holds all the necessary authorizations to perform the obligations covered by the contract in compliance with the regulations in force, in particular with regard to and without this list being exhaustive, health and safety rules, the conditions of employment of its personnel, as well as its good character.

TERRA MUNDI – VISIT OUEST undertakes to send a copy of the authorizations and insurance.

For this trip, TERRA MUNDI – VISIT OUEST has taken out a bank guarantee with Crédit Mutuel de Bretagne.

ARTICLE 11 – Support for service providers

TERRA MUNDI – VISIT OUEST declares to reserve all the services of the stays offered with each of the service providers listed in the price includes.

ARTICLE 12 - Confidentiality

The parties undertake to maintain the utmost discretion on all the information they may collect in the context of this commercial partnership.

The parties undertake to take all necessary measures to preserve and ensure that their respective personnel keep this confidential information.



ARTICLE 13 – Force majeure

Neither party shall be held liable vis-à-vis the other for the non-execution or delays in the execution of an obligation arising from this contract which would be due following the occurrence of a case of force majeure usually recognized by case law.

The case of force majeure suspends the obligations arising from this contract for the duration of its existence. However, if the case of force majeure had a duration of existence greater than thirty consecutive days, it would give rise to the automatic termination of this contract by one or other of the parties eight days after the sending of a registered letter with acknowledgment of receipt notifying this decision.

The cancellation of the SPACE event for any other case than that of force majeure will not be considered as a reason for cancellation.

ARTICLE 14 – TERMINATION - PENALTY

THE NON-PERFORMANCE BY ONE OF THE PARTIES OF ONE OF ITS OBLIGATIONS WILL RESULT IN THE AUTOMATIC TERMINATION OF THE CONTRACT FOLLOWING THE FORMAL NOTICE, SENT BY REGISTERED LETTER WITH ACKNOWLEDGMENT OF RECEIPT, WHICH HAS REMAINED UNSUCCESSFUL WITHIN A PERIOD OF FIFTEEN DAYS.

THE EXECUTION OF THIS CLAUSE DOES NOT PREJUDICE THE AWARD OF DAMAGES.

ARTICLE 15 - GENERAL PROVISIONS

THE FACT THAT ONE OF THE PARTIES HAS NOT DEMANDED THE APPLICATION OF ANY CLAUSE OF THIS AGREEMENT, WHETHER PERMANENTLY OR TEMPORARILY, CAN IN NO WAY BE CONSIDERED AS A WAIVER OF THE RIGHTS OF THIS PARTY. ARISING FROM SAID CLAUSE.

IT IS SPECIFIED THAT NOTHING IN THIS CONTRACT MAY BE CONSIDERED OR INTERPRETED AS CREATING BETWEEN THE PARTIES A LEGAL OR DE FACTO PARTNERSHIP, A MANDATE OR A SUBCONTRACTING AGREEMENT: EACH OF THE PARTIES RETAINS ITS FULL AUTONOMY, IN PARTICULAR AS REGARDS THEIR RESPECTIVE COMMERCIAL POLICIES, OF WHICH THEY ARE AND WILL NOT BE MUTUALLY INFORMED OTHER THAN FOR THE PURPOSES OF THIS CONTRACT.

ARTICLE 16 - APPLICABLE LAW AND JURISDICTIONS

THIS CONTRACT IS SUBJECT TO FRENCH LAW.

DIFFICULTIES IN INTERPRETATION OR ANY DISPUTES RELATED TO THIS CONTRACT WILL BE SUBMITTED TO THE COMPETENT COURTS OF RENNES.
